The two sides agreed to promptly communicate and pragmatically handle issues of concern related to the establishment of reciprocal institutions by the Straits Exchange Foundation (SEF) and the Association for Relations Across the Taiwan Straits (ARATS), (for example: full notification and the operations of the respective internal legal systems and supporting measures related to humanitarian visits, guaranteeing the security of the offices and their staffs, etc.) and to promptly complete negotiations.
